Dear Participant,

The National Kidney and Transplant Institute National Reference Laboratory (NKTI-NRL) for Hematology will be implementing the **National External Quality Assessment Scheme (NEQAS) in Blood Count** for 2022. Participation in this quality assurance exercise is one of the requirements of the Department of Health (DOH) for the renewal of the License to Operate (LTO) of clinical laboratories.

As per **DOH Department Memorandum no. 2009-0086B issued in September 8, 2014**, we shall be charging a **participation fee of three thousand and five hundred pesos (Php 3,500.00)**. 
We are currently accepting online registrations through our website www.nrl.nkti.org until May 31, 2022. In preparation for full implementation of our paperless NEQAS Information System by January 2023, we will no longer send printed or soft copies of the registration and payment slip forms beginning this year, and appeal to all laboratories to register online as early as possible. Rest assured that all laboratory registration data will be kept strictly confidential and will not be used for purposes outside of this quality assurance exercise without the laboratories' consent.

Your laboratory will receive an email of acknowledgement from the NKTI-NRL, as soon as we are able to successfully validate your online registration and your payment.
